	<p>Erin Antrim, Boys and Girls Clubs of Greater Oxnard and Port Hueneme</p> <p>Erin Reardon Antrim is the CEO of the Boys and Girls Clubs of Greater Oxnard and Port Hueneme, Ventura County’s largest Boys and Girls Club serving over 10,000 youth annually and 2,000 youth daily. Erin has grown the organization from 16 sites to 22 and increased the operating budget by over \$2 million annually. She holds a bachelor’s in liberal studies from San Diego State University and a master’s from California Lutheran University in educational psychology.</p>
	<p>Michael Brody, LightGabler</p> <p>Michael Brody litigates a broad range of employment and business matters in both state and federal court, as well as in administrative proceedings. Nominations by Petition. Nominations by Petitions may be accepted in accordance with the West Ventura County Business Alliance bylaws (Article IV, Section 5). “Additional names of candidates for directors can be nominated by petition bearing the genuine signatures of at least twenty-five (25) qualified members of the WVCBA. Such petition shall be filed with the Nominating Committee within ten (10) days after notice has been given of the names of those nominated. The determination of the Nominating Committee as to the legality of the petition(s) shall be final.” Petitions should be delivered to: West Ventura County Business Alliance, 400 E. Esplanade Drive, Suite 302, Oxnard CA 93036. If no petition is filed within the designated period, the nominations shall be closed and the nominated slate of candidates shall be declared elected by the Board of Directors at their regular October Board meeting.
